# Handelsbanken Wimbledon is closing during the second half of 2025.

Following a careful review we have made the difficult decision to close Wimbledon branch during the second half of 2025.

The team will relocate and combine with our team at Kingston Upon Thames branch.

At the same time, the combined branch will become known as 'Handelsbanken Kingston and Wimbledon'.

### Why is this happening?

We're committed to our branch-based business model and our branches will always be fundamental to how we run our decentralised bank and how we engage with our customers.

However, we need to evolve and adapt our business in line with changing customer behaviour and demands. Part of this adaptation involves making adjustments to our branch network to ensure we continue to be represented in the right areas to serve our customers in the best possible way.

Consideration to close Wimbledon branch has largely been driven by the benefits that a combined branch would bring for our customers and our staff, including:

- The greater efficiencies that a larger team will bring, allowing branch colleagues to better serve their customers;
- The additional support that will be created for branch colleagues as a result of a larger team; and
- Creating economies of scale for the branch to develop and grow further.

#### What this means for customers of Wimbledon branch

If you're a customer of Wimbledon branch you'll move to our new Kingston and Wimbledon branch during the second half of 2025.

Where possible your account manager will remain unchanged. If your account manager is changing, we'll let you know as soon as we can.

#### Getting there:

#### Public transport

The branch has good public transport links, with local bus stops within a four minute walk (0.2 miles); travel time between the two branches by bus is approximately 60 minutes during peak travelling hours. The train station at Hampton Wick is also a four minute walk (0.2 miles) from the premises, and travel to the branch from Wimbledon via National Rail is a 17 minute journey between Wimbledon and Hampton Wick stations.

#### Parking

For customers wishing to drive to the branch, the new location is approximately a 22 minute drive from Wimbledon branch via the A238. There's improved car parking facilities, with a free parking space on site and metered roadside parking on the Lower Teddington Road, which is two to three minutes' walk from the branch.

#### Opening hours and accessibility

The branch is open Monday - Friday, 9am - 5pm, the same as Wimbledon branch. The branch is located on the ground floor, which assists with accessibility.

#### Our service remains the same

The wider team will stay the same, and we'll continue to offer the same products and services.

Your sort code and account number(s), and existing Handelsbanken Debit and/or Charge Card(s) won't change, so you won't need replacement chequebooks or any new stationery.
